Any medical treatment cost is the responsibility of the parent. I further authorize the attending medical personnel to execute on my child(ren)'s behalf any permission forms, consents or other appropriate documents relating to medical attention. I agree to assume all liability for any expenses incurred in such an emergency (transportation, hospitalization, x-rays, etc.). I also understand and agree that For The Love Of Learning will notify me if my child(ren) becomes ill during school hours, and I will arrange to have my child(ren) picked up immediately from the school.

Education: The parent is responsible for the education of their child and making sure the child is completing all homework and will provide any additional homework the parent deems fit if the student doesn't attend F.T.L.O.L. full-time. Parents are responsible for testing and associated costs, and turning in attendance for days the children do not attend F.T.L.O.L. Since our school is based on each students' ability, not all students are placed in their age appropriate grade, instead, children are evaluated and placed based on their ability in each subject. Parents whose children attend F.T.L.O.L. understand that if the child is placed into another school, they may not be in the grade level for each subject that they should be based on their age.

## TUITION/FEES AGREEMENT

### Tuition and Registration Fee

Annual tuition per student is \$6,000 to be paid monthly at \$600 per month. Tuition is due in advance, the 1st of every month. A non-refundable registration fee of \$850 is due when the student is accepted to FTLOL, before their first day of school. Scholarship students see below for more information and calculations.

By signing this agreement, I/We agree to the following payment schedule:

August 13, 2018	\$600 Tuition + \$850 Registration Fee
September 1, 2018-May 1, 2019	\$600 the 1st of every month

### Late and Returned Check Fees

A late fee of **\$25.00** will be assessed for payments received after the 5<sup>th</sup> of every month, **\$50** after the 10th. If paid by scholarship this fee will be waived. Returned check fee of **\$35.00**.

### Testing Fees

Annual assessment tests will be administered at the end of the school year. These tests are optional unless the student's scholarship requires it. It is available for 3rd-12th Grade. The fee is \$50 and is included on the annual tuition invoice.

### Scholarships

The majority of scholarships that we accept do not cover the entire tuition plus registration fee as explained above. The student is responsible for the difference between the scholarship amount and the total tuition and registration fee (\$6,850). Scholarship students are required to pay ½ of the Registration Fee as a deposit. Deposit will be refunded when total tuition is received from the scholarship at the end of the school year or may be applied to the following school year. The annual amount that the scholarship will not cover is due by September 1st or within 30 days of registration if student enrolls after school has already begun. If the tuition amount due at registration is over \$500 or as needed, we will allow monthly payments, see Director or Assistant Director to request a payment plan. See Examples on the next page for clarification.

## Example 1: Scholarship pays \$6,550:

Amount due at registration \$425 deposit which will be refunded at the end of the school year if the student remains at FTLOL the entire year and tuition is paid.

Amount due by September 1st is \$300 (\$6,850-\$6,550)

## Example 2: Scholarship pays \$3,000: Total due from parent \$3,850 (\$6,850-\$3,000)

Amount due at registration \$1,235 (\$850 plus 1st monthly payment of \$385).

Tuition balance may be paid monthly (\$385 September 1st -May 1st).

## Withdrawal Terms

If the student is withdrawn before the end of the school year, a **30**-day written notice is required. I/We shall agree to pay a withdrawal fee of **1 month's** tuition (\$600). This fee is due regardless of whether withdrawal is based on the school's or the parent's decision. Student's records will be released upon payment of final invoice.

## Example of Withdrawal Invoice:

Student is withdrawn on October 15th and has Step-Up for Student Scholarship

Tuition (August-Oct) \$ 1,500 (\$600 Aug & Sept, \$300 Oct)

\*prorated weekly for the last month of attendance at the sole discretion of FTLOL

Withdrawal Fee \$ 600

Sub Total \$ 2,950

Minus Parent Payments -\$ 725 (\$425 deposit + \$300 tuition paid)

Minus Scholarship -\$1,300

**Total due at withdrawal \$ 925**
